**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

The undersigned being a duly authorized representative of a member, pursuant to the provisions of Florida Statutes Section 608.411, adopts the following Amended and Restated Articles of Organization of SEABED HOLDINGS, LLC, a limited liability company duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on January 7, 2010 (the "Amended and Restated Articles of Organization"):

ARTICLE I

NAME

The name of the limited liability company is SEABED HOLDINGS, LLC (the "Company").

OPERATING AGREEMENT



These Amended and Restated Articles of Organization of the Company are hereby executed this 30 day of March, 2010.


