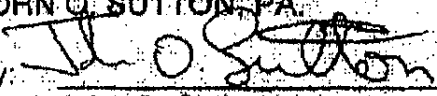

ARTICLE IV -- MANAGEMENT

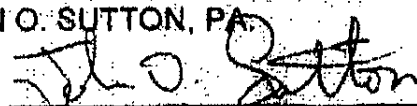

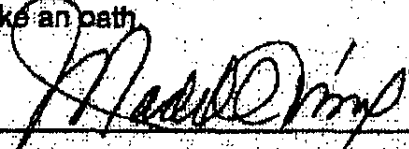

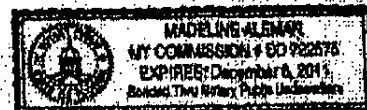
