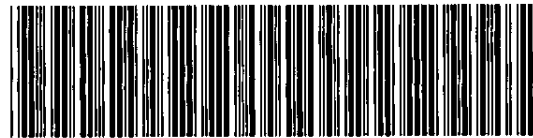

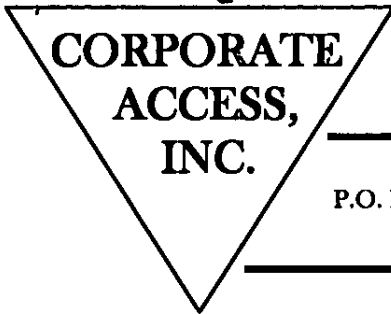

**WHEREAS**, pursuant to Article VII of Articles of Organization, Daniel M. Harvey is the Manager of the Company; and



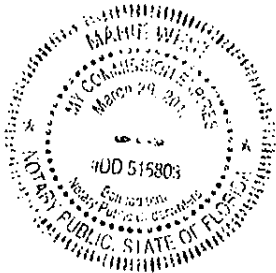


