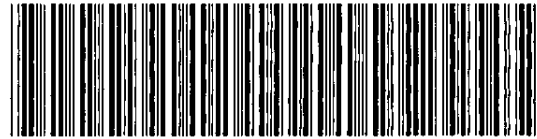

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I**  
Name

The name of the limited liability company (hereinafter referred to as the "Company") is 1823 N.W. 79th Street, LLC.

**ARTICLE II**  
Nature of Business and Mailing Address

The Company is organized for the purpose of transacting any or all lawful business. The mailing address and street address of the principal office of the Company is 9165 Park Drive, Miami Shores, FL 33138.

**ARTICLE III**  
Duration

Membership Certificates


