

ARTICLES OF ORGANIZATION OF TAMMY PRIDGEN ENTERPRISES, LLC

The undersigned, for the purpose of forming and limited liability company under the Florida Limited Liability Company act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be TAMMY PRIDGEN ENTERPRISES, LLC ("company").

ARTICLE II -- ADDRESS

The mailing and street address of the principal office of the company is 3197 CR 431 Lake Panasoffkee, Fl 33538.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

Pursuant to Fla. Stat. Section 608.415 or 608.507, the undersigned limited liability company submits the following statement to designate a registered office and registered agent in the State of Florida:

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
