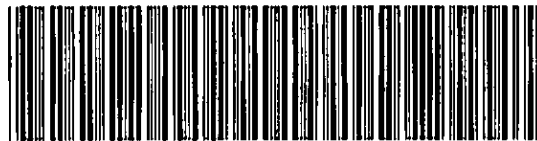


**ARTICLE 11**






