**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
FRESH ARTE, LLC**

The undersigned, being a duly authorized representative of a member, pursuant to the provisions of Florida Statutes Section 608.411, adopts the following Amended and Restated Articles of Organization of FRESH ARTE, LLC, a limited liability company duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on April 7, 2010 (the "Amended and Restated Articles of Organization"):

ARTICLE I

NAME

The name of the limited liability company is FRESH ARTE, LLC (the "Company").

ARTICLE II

PRINCIPAL AND MAILING ADDRESS

All Managers, other than the initial Managers, shall be appointed or elected solely as provided in the Operating Agreement.


