The undersigned, being desirous of forming a limited liability company pursuant to Chapter 608, Florida Statutes, hereby certifies as follows:


1. **Name of Limited Liability Company.** The name of the limited liability company is LIM-LIN-LAT, LLC, a Florida limited liability company (the "Company").


