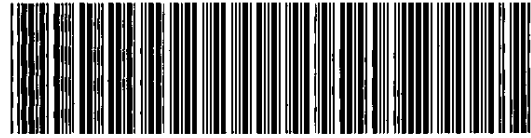



NAME




