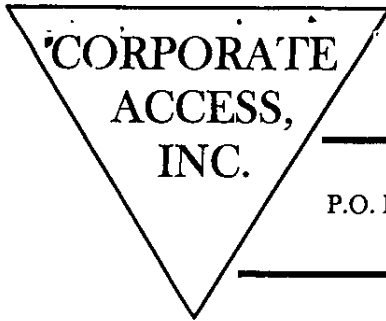

The undersigned hereby certifies that he is a member of Associated Otolaryngology Specialists, P.L. The following Articles of Organization are hereby adopted.

**ARTICLE I.**

**Name**

The name of the Company shall be Associated Otolaryngology Specialists, P.L.

**ARTICLE II.**

**Duration; Effective Date**

The Company shall exist perpetually, commencing as of the close of business on August 9th, 2010.

**ARTICLE III.**
