

## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF SELECT PHYSICIANS ALLIANCE, P.L.

These Amended and Restated Articles of Organization are filed in accordance with Section 608.411, Florida Statutes to amend the Articles of Organization of Associated Otolaryngology Specialists, P.L. initially filed August 9, 2010 and assigned document number L10000083552, and previously amended on May 12, 2011. The amendments include a change of the entity's mailing and principal address and the address for the registered agent. The amendments also include a change of the registered agent of Select Physicians Alliance, P.L. (the "Company"). The Company adopts its Amended and Restated Articles of Organization to operate a professional limited liability company under Chapters 621 and 608, Florida Statutes.

#### ARTICLE I. Name

Effective as of the filing date of these Amended and Restated Articles of Organization, the name of the Company shall be Select Physicians Alliance, P.L.

#### ARTICLE II. Duration; Effective Date

The Company shall exist perpetually, commencing as of the close of business on August 9th, 2010.

#### ARTICLE III. Address; Principal Office

The initial street and mailing address for the Company is 1149 Nikki View Drive, Brandon, Florida, 33511.

### ARTICLE IV. Initial Registered Office and Registered Agent

The address of the initial registered office of the Company is 1149 Nikki View Drive, Brandon, Florida, 33511, and the name of its initial registered agent at such address is Mike Mazeres.

#### ARTICLE V. Purpose

The Company may engage in any activity or business in the practice of medicine permitted under the laws of the United States of America and of this state.

#### ARTICLE VI. Restriction on Membership

Membership in the Company shall be limited to individuals who are licensed as physicians in the state of Florida under Chapter 458 or 459, Florida Statutes, and entities whose membership is limited to such individuals.

#### ARTICLE VII. Management

The Company shall be managed by one or more managers selected in accordance with its Operating Agreement

The undersigned, being an authorized representative of a member of the Company, hereby certifies that the foregoing constitutes the Amended and Restated Articles of Organization of Select Physicians Alliance, P.L., and that the amendments to the articles have been approved by a majority of the authorized members.
