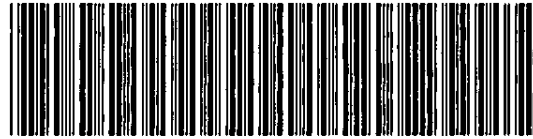



The Purpose of the meeting was to consider dissolution of the Company.



Upon motion duly made and seconded, the following resolution was approved by the members:
