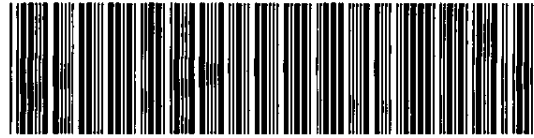

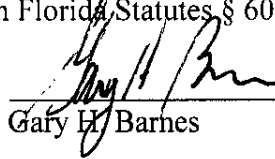
ARTICLES OF ORGANIZATION

September 10, 2010

The undersigned hereby form a limited liability company pursuant to Chapter 608 of the Florida Statutes as follows:

1. The name of the entity is Casula LLC (the "LLC").
2. The mailing address and the street address of the principal office of the limited liability company shall be 289 Montelluna Drive, North Venice, FL 34275.
