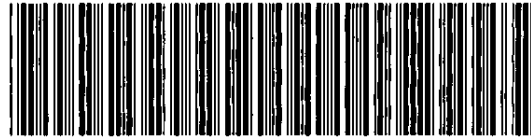

The name of the limited liability company shall be: **ODINTREE HOLDINGS, LLC** ("Company").

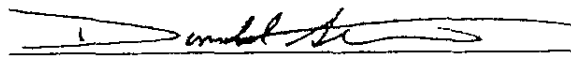

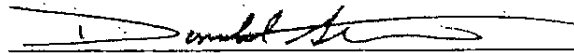
