A. The name of the company is CompCare Health Solutions, LLC (the "Company").

B. The Articles of Organization of the Company were filed with the Secretary of State on December 14, 2010, under the name CompCare of Clay County, LLC, and Articles of Amendment of the Articles of Organization of the Company were filed with the Secretary of State on March 24, 2011, changing the Company's name from CompCare of Clay County, LLC to CompCare Health Solutions, LLC.

C. An amendment and restatement of the Articles of Organization of the Company was adopted on May 31, 2012, by the sole member of this Company, and the Amended and Restated Articles of Organization have been duly executed and are being filed pursuant to Section 608.411, Florida Statutes (2011), to change the name of the Company and amend and restate the Articles of Organization of the Company in its entirety to read as follows:
