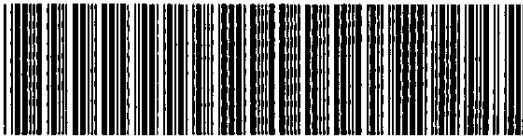

DURATION


