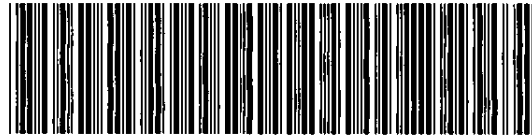


ARTICLE VI – GOVERNED BY OPERATING AGREEMENT
