ARTICLES OF ORGANIZATION

ARTICLE I
Name of Limited Liability Company

The name of this limited liability company is 15050 NORTH MIAMI SPECIAL MEMBER, LLC (the "Company"), with its principal place of business being located at 8600 8th Avenue, Montreal, Quebec, H1Z 2W4, and the mailing address is the same.

ARTICLE II
Duration

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

The members' interests in the Company shall be evidenced by certificates.
