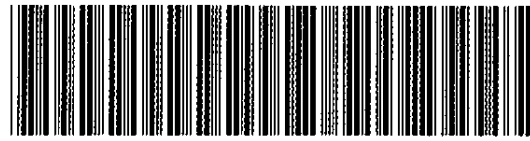




ADMISSION OF ADDITIONAL MEMBERS




