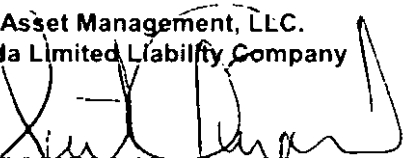
- a. Management. The business and affairs of the Company is managed by one or more Managers. The Managers shall direct, manage and control the business of the Company.
