

#### AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF PAPOLA, LLC.

Pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), the Articles of Organization of Papola, LLC., are amended and restated to read in their entirety as follows:

ARTICLE 1 NAME

The name of the company is PAPOLA, LLC. (the "Company").

ARTICLE 2 DURATION

The period of duration of the Company is perpetual.

ARTICLE 3
PURPOSE

The purposes for which the Company is organized are to engage in any lawful act or activity for which corporations may be organized under the Florida Limited Liability Company Act.

The management of the Company is vested in the managers; and the managers shall have power to exercise all the powers of the Company, including (but without limiting the generality hereof) the power to create mortgages upon the whole or any part of the property of the Company, real or personal, without any action of or by the members, except as otherwise provided in the Company's operating agreement.

#### **ARTICLE 6** LIMITATION OF LIABILITY OF MANAGERS AND MANAGING MEMBERS

The liability of the managers and managing members of the Company for monetary damages shall be eliminated to the fullest extent permissible under Section 608.4228 of the Florida Limited Liability Company Act.

#### ARTICLE 7 INDEMNIFICATION OF COMPANY'S AGENTS.

Subject to the applicable limits set forth in Section 608.4229(2) of the Florida Limited Liability Company Act, the Company is authorized to provide indemnification of its members, managers, managing members, officers, employees, and agents through operating agreement provisions.

The foregoing amendment and restatement of these Articles of Organization has been duly approved by the Manager.
