ADDRESS**

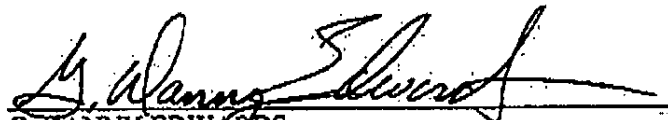

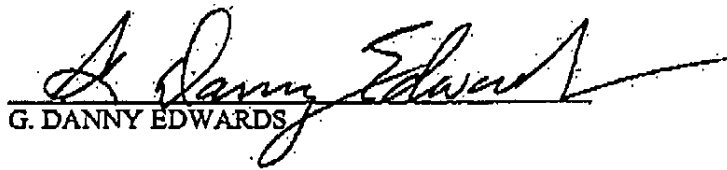
