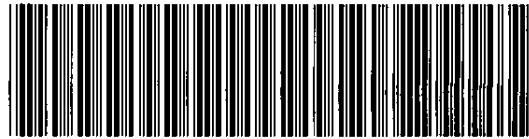


**Article I - Name.** The name of the limited liability company shall be "WhereToWatch, LLC." (hereinafter the "Company").
