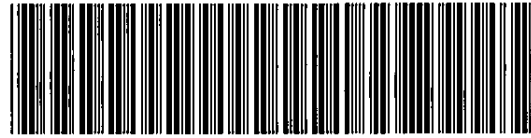



**ARTICLES OF AMENDMENT OF

The undersigned member, acting pursuant to §608.4231, Florida Statutes, as amended, hereby adopts the following Articles of Amendment of Articles of Organization (these "**Articles of Amendment**").

1. **COMPANY NAME.** The current name of the Company has been and is "1144 FAIRFAX DRIVE, LLC".
2. **DATE OF FILING OF THE ARTICLES OF ORGANIZATION.** The articles of organization were filed on May 25, 2011.
3. **AMENDMENTS ADOPTED.** This Amendment provides for the Company's change of name. The text of the amendment is as stated below.

Name**


The name of this Company shall be: "1144 Fairfax Drive, LLC".
