AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF ARTI MEDIA HOLDINGS, LLC

First: The Articles of Organization of ARTI Media Holdings, LLC were filed on June 6, 2011 and assigned Document Number L11000065992.
