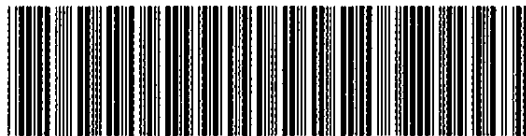

NAME
