**ARTICLES OF ORGANIZATION  
OF  
5784 STRAWBERRY LAKES CIRCLE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I – Name**

The name of the Limited Liability Company is 5784 STRAWBERRY LAKES CIRCLE, LLC (the "Company").

**ARTICLE II – Address**

The mailing address and street address of the principal office of the Company is:

**ARTICLE III – Duration**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE IV – Registered Agent and Registered Office**

The name and street address of the registered agent and registered office of the Company in the State of Florida is Alan Bias, 7745 Dawson Court, Lake Worth, Florida, 33467.

**ARTICLE V – Capital Contributions**

Capital contributions in cash or in kind shall be paid to the Company by the members in such amounts as the Managing Members shall determine.

**ARTICLE VI – Additional Capital Contributions**

Each member shall make additional capital contributions to the company only upon the unanimous consent of the Managing Members.

**ARTICLE VII – Admission of New Members**

No additional members shall be admitted to the Company except with the unanimous written consent of the Managing Members of the Company and upon such terms and conditions as shall be determined by the Managing Members. A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless the Managing Members of the Company approve of the proposed transfer by unanimous written consent. **ARTICLE VIII – Termination of Existence**

The Company shall be dissolved upon the death, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there is at least one remaining member.

**ARTICLE IX – Management**

The Company shall be managed by a manager or managers in accordance with regulations (the "Operating Agreement") adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
