**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
SALTY VENTURES OF CORAL SPRINGS, LLC**

The undersigned member of **SALTY VENTURES OF CORAL SPRINGS, LLC**, a limited liability company organized and existing under the laws of the State of Florida (the "**Company**"), whose Articles of Organization were originally filed with the Florida Department of State on July 26, 2011, adopts the following Amended and Restated Articles of Organization of the Company:

ARTICLE I
Name

The name of the Company is Salty Ventures of Coral Springs, LLC.

ARTICLE II
Principal and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III
Registered Office and Registered Agent

The registered office of the Company shall be located at 101 E. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

The operating agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.
