ARTICLES OF ORGANIZATION

ARTICLE VI - TERMINATION OF EXISTENCE

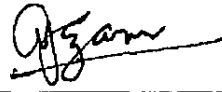
The Company shall be dissolved upon the agreement of the members.

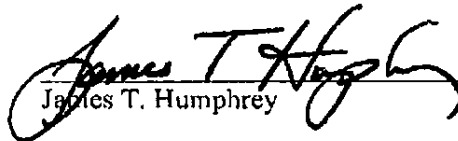
