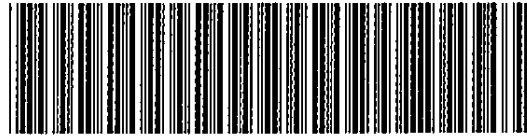

ARTICLE VI
ADMISSION OF ADDITIONAL MEMBERS

No additional members shall be admitted to the Limited Liability Company except with the unanimous written consent of all the members of the limited liability company and upon such terms and conditions as shall be determined by all the members. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members of the limited liability company shall have the right to continue the business of the limited liability company, provided that all remaining members consent to the continuation and there is at least one remaining member.


