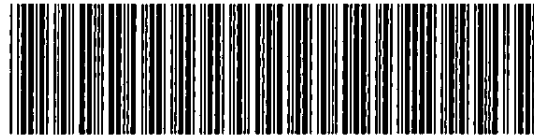

ARTICLES OF ORGANIZATION
FOR
NASAJON VENETIA, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - NAME

The name of the Limited Liability Company is: NASAJON VENETIA, L.L.C.

ARTICLE II - DURATION

The limited liability company shall have perpetual existence.
