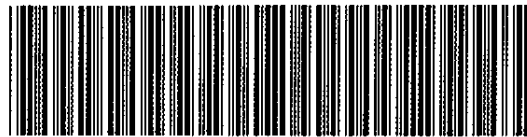

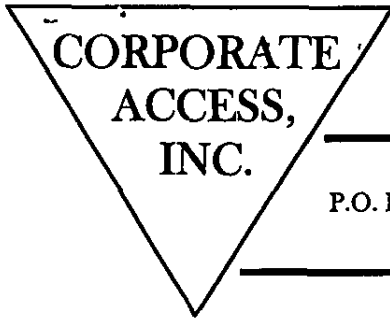

**ARTICLE I.  
Name**
