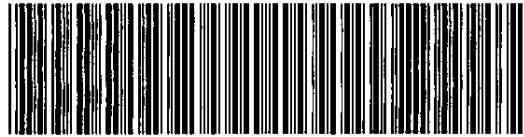





The power to adopt, alter, and amend the Operating Agreement shall be vested in the Members.


ARTICLE VI – INDEMNIFICATION


