#### ARTICLES OF ORGANIZATION

OF

#### MANDARIN COVE OFFICE, LLC



In accordance with the provisions of the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, (the "Act") the undersigned, sole organizer of a Florida limited liability company, and an authorized representative of a Member of the Company hereby files these Articles of Organization:

#### ARTICLE I -- NAME

The name of the limited liability company is MANDARIN COVE OFFICE, LLC (the "Company").

#### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company in the State of Florida is 2950 Halcyon Lane, Suite 604, Jacksonville, Florida 32223.

#### ARTICLE III -- REGISTERED AGENT & OFFICE
