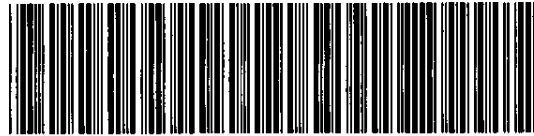

NAME**

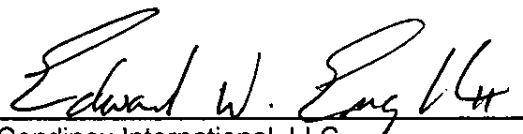
81 The Manager (s) so elected shall perform the duties and responsibilities fixed by the
