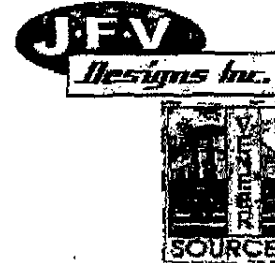


Dear Ms. McLeod,

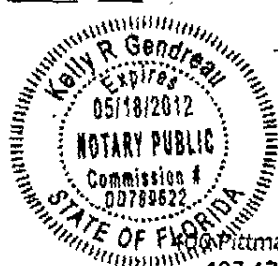
