ARTICLES OF ORGANIZATION OF 13 LPR LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be 13 LPR LLC ("Company").

ARTICLE II - ADDRESS

The mailing address of the principal office of the Company is 1501 Orange Avenue, Tavares, Florida 32778. The street address of the Company is 1501 Orange Avenue, Tavares, Florida 32778.

ARTICLE III - DURATION
