Pursuant to the provisions of Section 605 of the Florida Statutes, the above Florida professional limited liability company submits the following to amend its Articles of Organization:

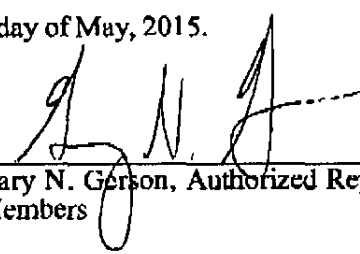
