AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF AVIASERVICE INTERNATIONAL, LLC

WHEREAS, on March 1, 2012, the initial articles of Aviaservice International, LLC (the "Company") were adopted and filed with the Florida Department of State ("Original Articles"); and

WHEREAS, the members of the Company have determined that it is in their best interest to adopt revised articles for the Company in the form hereof; and

ARTICLE I

NAME
