**ARTICLES OF ORGANIZATION  
OF  
REUS ATLANTIC LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

**ARTICLE I. NAME**

The name of the limited liability company is REUS Atlantic LLC (the "Company").

**ARTICLE II. MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 701 Brickell Avenue, Suite 1720, Miami, Florida 33131, Attention: Claudio Zichy.

**ARTICLE III. REGISTERED AGENT AND OFFICE**

**ARTICLE IV. DURATION**

The Company shall commence its existence on the date that the Articles are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in the Operating Agreement.

**ARTICLE V. MANAGEMENT**

The Company shall be managed in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The initial Manager of the Company will be REUS Atlantic Inc., a Delaware corporation, 701 Brickell Avenue, Suite 1720, Miami, Florida 33131.


