1. Name. The name of the limited liability company is CRUNCH NAPLES, LLC (the "Company").
2. Articles of Organization. The date of filing of the Articles of Organization of the Company was May 2, 2012 and with effective date of April 30, 2012 (Document Number L12000059775).
3. Amendment. The Articles of Organization of the Company are hereby amended as follows:


Article V is deleted and a new Article V is inserted in lieu thereof, to read as follows:

ARTICLE V
MANAGEMENT
