**ARTICLES OF ORGANIZATION  
OF

The undersigned person, acting as the organizer of GH&G SPRING HILL, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**

The name of this limited liability company is:

**ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE**
