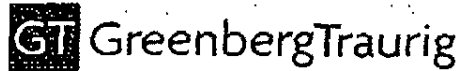

ARTICLE IV - Management




