The undersigned, ROBERT S. ZIMMERMAN, KARIN S. ZIMMERMAN, and LANNY W. ZIMMERAN, natural persons competent to contract and members of ZIMMERMAN PROPERTIES, LLC, hereby present these Articles of Organization as the Articles of Organization of ZIMMERMAN PROPERTIES, LLC, a limited liability company formed under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes* (the "Act").

**ARTICLE I - NAME**

The name of the limited liability company is ZIMMERMAN PROPERTIES, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The street address and mailing address of the principal office of the Company is 56 S. Alcaniz Street, Pensacola, Florida 32502.

**ARTICLE III - PURPOSES AND POWERS**

The Company is organized for any legal and lawful purpose for which a limited liability company be organized and shall have all powers and rights which a limited liability company may exercise under the Act, as such Act presently exists and may hereafter be amended.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

**ARTICLE V - REGISTERED OFFICE AND AGENT**

The address of the registered office of the Company is 56 S. Alcaniz Street, Pensacola, Florida 32502, and the name of the registered agent at that address is Robert S. Zimmerman.

**ARTICLE VI - MANAGEMENT**

The Company shall be a manager-managed limited liability company and will be managed in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial Managers of the Company are as follows:

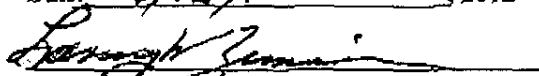
**ARTICLE VIII - AMENDMENT**
