Weltman, as tenant by the entirety, owners of 100% of the Class B Non-Voting Membership Interests; (ii) Nicole L. Weltman, owner of 50% of the Class A Voting Membership Interests; and (iii) Jason M. Weltman, owner of 50% of the Class A Voting Membership Interests. Upon the Effective Date of the Merger, the members of NWJ Gator Investments, LLC. shall retain their membership interests.

NWJ Gator Investments, LLC. shall not issue any additional units, evidencing a membership interest in NWJ Gator Investments, LLC. to the member of CMJM Properties, LLC because NWJ Gator Investments, LLC. is the owner of 100% of the membership interests of the merged entity.
