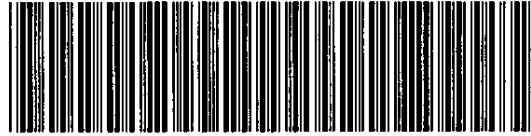

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

FIRST: The name of said limited liability company shall be PEACOCK LOT 2, LLC.

SECOND: PEACOCK LOT 2, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of PEACOCK LOT 2, LLC may be obtained from the Manager at 100 SE 2 Street, Suite 2370, Miami, Florida 33131 which is the place in the State of Florida where the principal office of the limited liability company is located. 

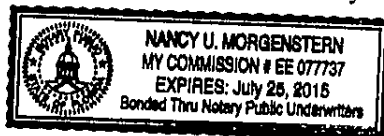
