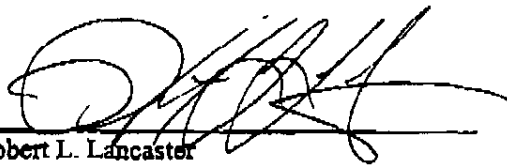
ARTICLE VII
