

ARTICLES OF ORGANIZATION

VINAYAK, LLC

A LIMITED LIABILITY COMPANY



- 1. Name. The name of the limited liability company is VINAYAK, LLC.
- 2. <u>Purpose.</u> The purpose of this limited liability company is real estate acquisition and management and may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
- 3. Address of Principle Office. The address (mailing and street address) of the registered office of the limited liability company is 5950, Masters Boulevard, Bayhill Orlando, FL 32819
- 4. **Term.** Term of this LLC shall be perpetual.
- 5. <u>Members at Time of Formation</u>. There will be at least one member at the time the limited liability company is formed.
- 6. <u>Period of Duration.</u> The period of duration shall be perpetual.
