ARTICLES OF ORGANIZATION OF FINGER & NELSON, PL

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, *Florida Statutes* Chapter 608 and the Professional Service Corporations Limited Liability Companies Act, *Florida Statutes*, Chapter 621 hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be FINGER & NELSON, PL (the "Company").

ARTICLE II - ADDRESS
