**ARTICLES OF ORGANIZATION
OF

The undersigned person, acting as the organizer of G H & G E COLONIAL, LLC , under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

The existence of the company will commence on the date these Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

ARTICLE IX - TERMINATION OF MEMBERSHIP INTEREST




ACCEPTANCE OF REGISTERED AGENT
